**ORDINANCE AMENDING THE VILLAGE OF  
WONDER LAKE CODE OF ORDINANCES**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF WONDER LAKE as follows:

SECTION 1: That CHAPTER 110 BUSINESS LICENSING AND REGULATIONS,  
Section 110.06 SOLICITORS paragraph (B) Fee shall be amended to the following:

§ 110.06 SOLICITORS paragraph (B) Fee.

Each registrant shall pay to the Village Clerk a registration fee of \$100.00 per person for 5 days for all companies except ice cream trucks. Ice cream truck registration fee is \$50.00 for the company and runs from May 1 to October 31.

SECTION 2: That CHAPTER 110 BUSINESS LICENSING AND REGULATIONS, section 110.06 SOLICITORS paragraph (H) shall be added as follows:

§ 110.06 SOLICITORS paragraph (H) Time Limit on soliciting

It is hereby declared to be unlawful and shall constitute a nuisance for any person to go upon any premises in the Village and ring the doorbell upon or near any door of a residence location thereon, or rap or knock upon any door, or create any sound in any other manner calculated to attract the attention of the occupant thereof and engage in soliciting prior to 10:00a.m or after 6:00p.m. on any day other than Sunday or a national or state holiday. No soliciting shall be lawful on Sunday or a national or state holiday, except for ice cream trucks. Ice cream trucks may silicate Monday through Sunday from 10:00a.m. to 8:00p.m.

SECTION 3: That CHAPTER 110 BUSINESS LICENSING AND REGULATIONS, section 110.99 PENALTY paragraph (F) shall be amended to the following:

§ 110.99 PENALTY paragraph (F)

Any person violating the provisions of § 110.06 of this chapter shall be punished by a fine of not less than \$250, nor more than \$500. Each solicitation of a different person shall constitute a separate violation under the terms of § 110.06 of this chapter.

SECTION 4: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 5: That all Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

SECTION 6: That this Ordinance shall be in full force and effect from and after its passage and approval according to law.
