**RESOLUTION SETTING THE VACATION
RENTAL REGISTRATION FEE**

WHEREAS, the Village of Wonder Lake adopted an ordinance for vacation rental requirements and procedures; and

WHEREAS, Section 7 paragraph B provides that the Village shall establish by resolution the vacation rental registration fee.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WONDER LAKE, McHENRY COUNTY, ILLINOIS, as follows:

SECTION 1: The vacation rental registration fee shall be established at \$150.00 annually.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Resolution shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Resolution shall be in full force and effect upon its passage, approval and publication as provided by law.


